


How does the system work?

Clarification Text on the Protection and Processing of Personal Data

As a "Data Controller" within the scope of the Law No. 6698 on the Protection of Personal Data; we carry out the responsibility of data processing and protection activities such as the collection of personal data, for what purpose the collected data will be used, whether it will be shared, with whom it will be shared if it will be shared, how long it will be stored, the rights of data owners, within the limits of the law and legislation.

a) For what purpose personal data will be processed

In the processing of personal data, the principles of compliance with the law and good faith, having a legitimate basis, not having consequences to the detriment of the individual, transparency, accuracy of the data, certainty of the sources obtained, updating the data due to inaccuracy are complied with.

Personal data are retained for the period stipulated in the relevant legislation or for the period required for the purpose for which they are processed.

Personal data are processed in accordance with the Personal Data Protection Legislation, legal regulations in Turkish law regarding the protection of personal data and as expressly stipulated in the laws.

Your personal data;

- Execution and development of the business and academic processes of our university and utilization of these services within the scope of educational activities,
- In line with the purpose of carrying out the personnel policies of our University; in accordance with the personnel policies of the University; carrying out its operations, recruiting personnel suitable for open positions, fulfilling the obligations and taking the necessary measures within the framework of the Labor Law, Social Security Law and other legislation regulating business life, occupational health and occupational safety,
- Within the framework of contracts or activities carried out with third real or legal persons who
 have a business relationship with the University; execution of obligations arising from contracts
 made by the University with business partners / customers / suppliers, establishment of rights,
 protection of rights, commercial and legal evaluation processes, execution of financial affairs in
 order to realize legal and commercial obligations,
- Carrying out the necessary work for you to benefit from the services of our University by the
 relevant units, contacting you through the communication channels you have shared with us,
 promoting our University and its activities, ensuring that the relevant people benefit from the
 products and services offered by the University, ensuring your registration at the University and
 so on,
- Meeting the obligations regarding educational activities and supervision and other obligations imposed by the Higher Education Law and the Higher Education Council (YÖK), continuing education, scientific research, publication and consultancy activities, establishing rights arising from educational activities within the scope of higher education legislation and internal regulations of the University, producing and printing identity cards and performing various academic and administrative procedures,
- Your data may be used to protect the safety of life and property of university students/employees/visitors, to fulfill the requirements or requests of legal obligations, judicial bodies or authorized administrative bodies. The data may be processed for the execution of activities such as archiving in electronic or physical media in order to fulfill legal obligations in order to fulfill the purposes mentioned here by taking the necessary security and legal measures.

Your personal data may be collected verbally, in writing or electronically by the units of our University by automatic or non-automatic methods depending on the relationship between you and our University; It will be updated as long as your relationship with our University continues and the mandatory data will be updated as long as your relationship with our University continues and the mandatory data can be processed by our University as the Data Controller within the personal data processing conditions and purposes specified in Articles 5 and 6 of the KVK Law No. 6698 in order to fulfill our legal responsibility.

b) To Whom and For What Purpose the Processed Personal Data May Be Transferred The data transfer carried out within our University, which has the title of Data Controller, cannot be considered as transfers made to third parties. The exchange of data among employees or different units operating within our University does not constitute a transfer to a third party in this sense.

Your personal data; for the purposes of carrying out the necessary activities by the relevant business units so that you may benefit from education, health, and employment services by our University, which has the title of data controller, the execution of academic and administrative activities, ensuring the legal and commercial security of our University and persons who have a business relationship with our University, ensuring physical security and supervision at the internal and external locations of university facilities and buildings, carrying out legal compliance processes, fulfilling financial transactions; may be transferred, to the extent limited to the personal data processing conditions and purposes specified in Articles 8 and 9 of Law No. 6698, to legally authorized public institutions such as the Higher Education Council, SGK, ministries, judicial authorities, institutions with which cooperation is made in cases permitted by legislation, parties, contracted institutions, payment system institutions.

c) Method and Legal Reason for Collecting Personal Data

Your personal data is obtained for the purposes stated above in order for our services to be provided and for our University to fulfill its contractual and legal obligations completely and accurately within this scope. Your personal data collected on this legal basis may be processed and transferred for the purposes specified in articles (a) and (b) of this text within

the scope of the personal data processing conditions and purposes specified in Articles 5 and 6 of the Personal Data Protection Law No. 6698.

- d) Rights of the Personal Data Owner Listed in Article 11 of Law No. 6698 As personal data owners, if you submit your requests regarding your rights to our University through the methods regulated below, our University will conclude the request free of charge as soon as possible and within no later than thirty days depending on the nature of the request. However, if the process requires an additional cost, the fee in the tariff determined by the Personal Data Protection Board will be collected by our University. In this context, personal data owners have the right to:
- whether Learn personal data is being processed or not, information if personal data has been Request processed, • Learn the purpose of personal data processing and whether they are used in accordance with their purpose,
- Know the third parties to whom personal data is transferred within the country or abroad,
- Request the correction of personal data if they are incomplete or incorrectly processed, and request that the transaction carried out in this context be notified to the third parties to whom the personal data has been transferred,
- Request the deletion or destruction of personal data in case the reasons requiring its
 processing cease to exist, although it has been processed in accordance with the provisions
 of Law No. 6698 and other relevant laws, and request that the transaction carried out in this
 context be notified to the third parties to whom the personal data has been transferred,
- Object to the emergence of a result against the person as a result of the analysis of the processed data exclusively through automated systems,
- Request compensation in case of damage due to unlawful processing of personal data.

In accordance with Article 13, paragraph 1 of Law No. 6698, you may submit your request regarding exercising the above-mentioned rights to our University in writing or through other methods determined by the Personal Data Protection Board. Since the Personal Data Protection Board has not determined any method at this stage, you are required to submit your application to our University in writing pursuant to Law No. 6698.
